CIROBE is a table top show. All materials must be displayed and sold from the top of these tabletops. Any exceptions must be submitted in writing to CIROBE at least one month prior to the show and could result in additional fees. Exhibitor badges will be issued only to actual employees of the exhibiting firms. Information on drayage costs and other services and costs will be included in later mailings. Participation in CIROBE requires compliance with the rules of other organizations as well as those of CIROBE, these organizations include, but are not limited to, the Hilton Chicago, Freeman Decorating Company, and the Chicago Fire Marshall.

Exhibitor Agreement

Exhibitor applies to rent a booth or booths at the Chicago International Remainder and Overstock Book Exposition (Exhibition). Upon receipt of payment and confirmation of this agreement by CIROBE, the Chicago International Remainder and Overstock Book Exposition, Inc. (CIROBE) agrees to provide such booth space as is available to Exhibitor. CIROBE retains the right to determine the placement of Exhibitors within the Exhibition, and to establish rules regarding hours of operation and the operation of the Exhibition. Exhibitor agrees that it will not sublet or assign its space at the Exhibition without prior consent of CIROBE.

Exhibitor may cancel this contract if it gives written notice of cancellation on or before September 1, 2008, in which event CIROBE shall refund 50% of any payment Exhibitor has made. Otherwise, this contract is non-cancellable. CIROBE may cancel this contract if circumstances outside of its reasonable control (including but not limited to destruction of the hall, terrorism, labor disputes, substantial disruption of normal modes of transportation or acts of god) render it impossible or impractical to hold the Exhibition on the scheduled dates, in which event CIROBE shall refund to Exhibitors their prorata share of CIROBE's net receipts for the Exhibition (gross receipts less costs relating to the Exhibition), but not be responsible for any other losses or consequential damages.

CIROBE and its agents and employees shall not be responsible for any injury or loss to the Exhibitor or its employees during or because of the Exhibition, including personal injury or damage to property. Exhibitor assumes responsibility and agrees to indemnify CIROBE, the Chicago Hilton and Towers, and their respective employees and agents against any claims and expenses arising out of the use of the exhibition premises. Exhibitor understands that neither CIROBE nor the Hilton Chicago maintains insurance covering the Exhibitor's property, and it is the sole responsibility of Exhibitor to obtain such insurance.
